- ✓ In 2024, LONGi Green Energy Technology received EcoVadis Silver Rating, scoring 69 points, placing it in the top 15 percent among all rated companies in the past 12 months.
- ✓ EcoVadis rating is a measure of the quality of the company's sustainability management system.
- ✓ The assessment methodology is based on 21 sustainability topics under 4 categories, including environment, labour & human rights, ethics, and sustainable procurement.



## OUR GHG EMISSIONS REDUCTION TARGETS ARE VERIFIED BY SBTi TO BE ALIGNED WITH 1.5°C PARIS AGREEMENT GOAL

↓ 60% Operational GHG emissions reduction in 2030 compared to 2020

↓ 52% Value Chain GHG emissions intensity reduction in 2030 compared to 2020

- ✓ In 2023, we became the first Chinese PV module manufacturer to have GHG emissions reduction targets verified by Science Based Targets Initiative. Our operational emission reduction targets are aligned with 1.5°C Paris Agreement Goal.



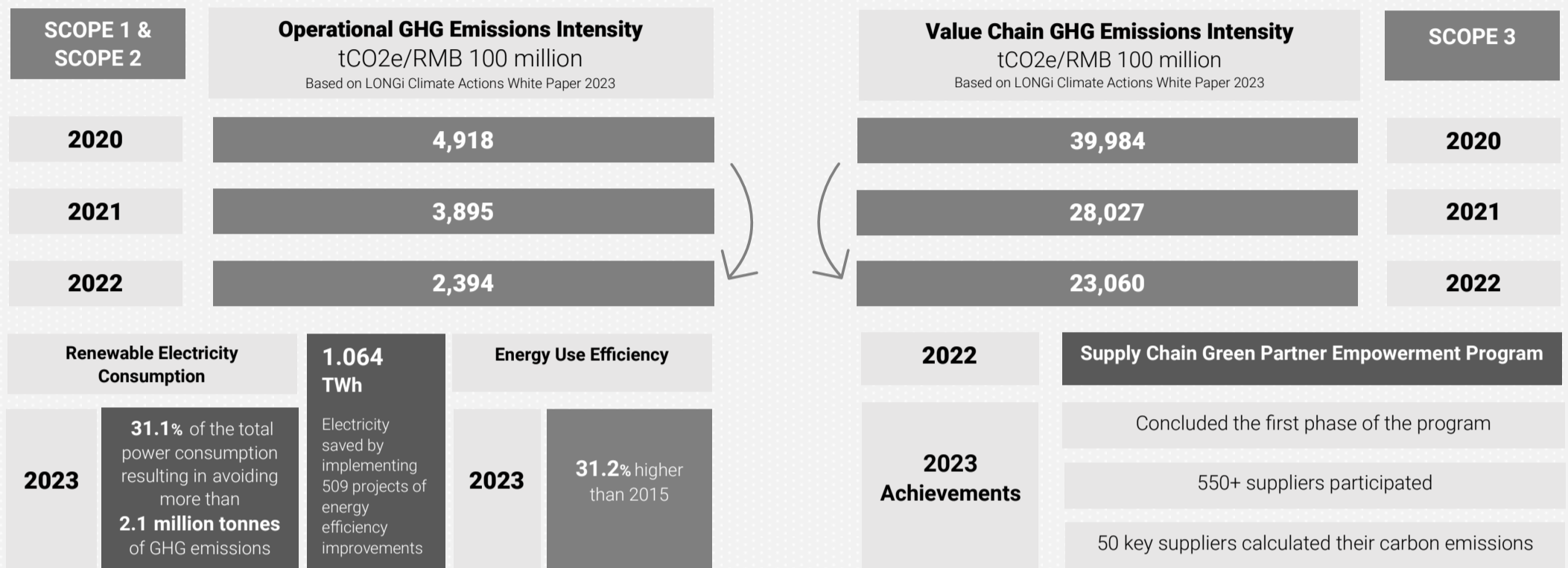

Several Hi-MO series products have been certified with the 'Product Carbon Footprint Declaration' issued by BUREAU VERITAS in accordance with ISO 14067. Environmental Product Declaration (EPD) are available for several of our module products, presenting the lifecycle environmental impact assessment associated with them.

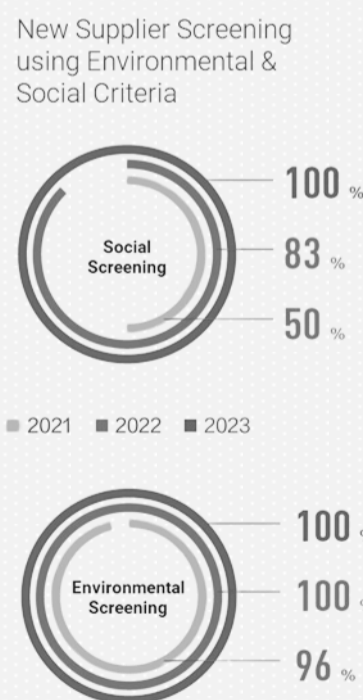
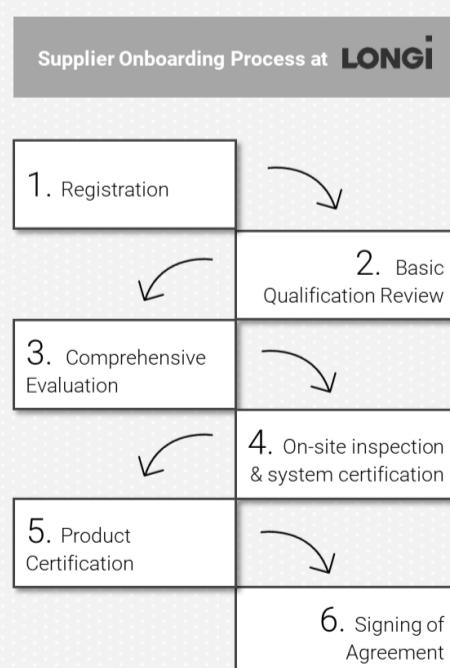
